1 **SEC. 3314. PROHIBITION ON ALLOCATIONS OF SPECIAL**
2 **DRAWING RIGHTS AT INTERNATIONAL MONE-**
3 **TARY FUND FOR PERPETRATORS OF GENO-**
4 **CIDE AND STATE SPONSORS OF TERRORISM**
5 **WITHOUT CONGRESSIONAL AUTHORIZATION.**

6 Section 6(b) of the Special Drawing Rights Act (22
7 U.S.C. 286q(b)) is amended by adding at the end the fol-
8 lowing:

9 “(3) Unless Congress by law authorizes such action,
10 neither the President nor any person or agency shall on
11 behalf of the United States vote to allocate Special Draw-
12 ing Rights under article XVIII, sections 2 and 3, of the
13 Articles of Agreement of the Fund to a member country
14 of the Fund, if the government of the member country
15 has—

16 “(A) committed genocide at any time during
17 the 10-year period ending with the date of the vote;
18 or

19 “(B) been determined by the Secretary of
20 State, as of the date of the enactment of the Stra-
21 tegic Competition Act of 2021, to have repeatedly
22 provided support for acts of international terrorism,
23 for purposes of—

24 “(i) section 1754(c)(1)(A)(i) of the Export
25 Control Reform Act of 2018 (50 U.S.C.
26 4813(c)(1)(A)(i));

- 1 “(ii) section 620A of the Foreign Assist-
- 2 ance Act of 1961 (22 U.S.C. 2371);
- 3 “(iii) section 40(d) of the Arms Export
- 4 Control Act (22 U.S.C. 2780(d)); or
- 5 “(iv) any other provision of law.”.
